- All the players have to report 45 minutes prior to your match scheduled.
- Tournament Committee is NOT liable for any injuries sustained during the course of the tournament on or off the field, during or apart from the match and for loss of any equipment/money/any other belongings.
- Strictly, Only NON MARKING footwear is allowed in Badminton and Table Tennis.
- *Upon agreeing to participate in the event, the participant and the team management agrees that/they are doing so by their free will and waives SPT Sports, its employees, the sponsors and all associates of the event, from any liability or claims arising from any loss, injury, untoward incident during the course of the event. The sponsors, organizers or their associates will not be liable for any liability in case of injury*

#### First Aid

Tournament committee will provide for basic first aid kit on the ground. In case a player gets injured and needs medical attention, all the medical expenses have to be borne by the player or his company. Under no circumstances, Tournament Committee can be held liable for any such expenses.

#### Security of Valuables
